COVID-19 Safety Operational Guidelines

All persons must follow all current regulations of the California State and the City of San Diego. Everyone must wear a face covering when not actively playing on court or umpiring. Failure to do so may result in removal from the venue.

All persons experiencing physical symptoms possibly related to COVID-19, including coughing or fever, are prohibited from entering the venue.

Participants are not permitted to be closer than six feet to the Tournament Director's work area. Participants can only consume their food outside of the venue.

3. **Events and Eligibility:**

USAB Ranking "A" level events are open only to the current members of USA Badminton or another country's BWF Affiliate. Proof of membership is required at registration.

'A', 'B', 'C', 'D' Singles, Doubles, Mixed Doubles
Senior (40+), Master (50+), Grand Master (60+) Singles
Combined age Senior Doubles and Mixed Doubles (80+ to 120+)
Senior Events Eligibility: As of 01/01/2022, age 40 or older.

To maintain fairness to other participants, Tournament Director/Referee reserves the right to adjust or deny entry (entry fee to be refunded) by a player to an event that is not suitable for his/her play level. Events with low entries may be combined or canceled. A player is limited to 3 events. A junior player who registers to play the Dave Freeman Jr. OLC (See separate Prospectus. Registration: <https://bit.ly/DFJr2022>) can play a maximum of 4 combined events in the OLC (limited to 3) and this Dave Freeman Open.

Consolation matches will be played for all events with elimination draws. Players losing their first match in a draw will be placed into the consolation draw.

Yonex tournament grade shuttles will be used. Each match is limited to 2 shuttles except for A events.

Draws will be published on tournamentsoftware.com. Results and match time will be updated periodically.

6. **REGISTRATION FEES:**

A Events:

First event = \$70; (at the [Extra's] section, you need to click "Yes" to the "A Events" box and pay the additional \$30 A event fee).

Second or third event = \$30 each.

Please also enter your USAB membership # in your Profile under "Sport Information"

All other Events except for A:

First Event = \$40

Second or third event = \$30 each.

Payment is required before the entry deadline. Unpaid entries will NOT be placed into the draw.

For doubles events, each player must register and pay separately. You will NOT receive a refund if your partner does not register and pay by the entry deadline, but you may play with another registered player if available.

Registering at the tournament desk is required prior to the start of a participant's first match.

7. **DEADLINES/REFUNDS:**

The earlier of

(a) when tournament reaches the 250-player cap, or

(b) Sunday 02/14/2022, 11:59pm,

is the deadline for entry, withdrawal and payment. Entries or payments made after this time may be accepted at the discretion of the Tournament Director with a late fee of \$20.

Refunds after withdrawal deadline: You will receive a full refund ONLY for

(1) an Event cancelled by the Tournament Director & Referee;

(2) an Event you have been removed by the Tournament Director & Referee to limit sandbagging.

You will receive a partial refund for the withdraw from the Tournament due to medical reasons which will require a physician's note. A processing fee of \$20 will be withheld.

Absolutely NO REFUNDS after the draw is published.

8. **Schedule:**

'A' events start on Friday. Senior events may start on Friday depending on the draw. All other events start on Saturday.

'A' event finals will be held on Sunday starting 11 am.

5:00 pm to 11:00 pm on Friday

9:00 am to 11:00 pm on Saturday

9:00 am to 7:00 pm on Sunday

(Subject to change without notice)

Scoring: Current BWF scoring system (3x21 rally points).

Default: Players not present when their match is called may be defaulted after ten (10) minutes.

9. **Awards/Cash Prizes:** Medals will be awarded to winners, runners up and either third place or consolation winners in all events.

A player/pair needs to win at least one match to win any cash/merchandise prize.

\$12,000.00 prize purse for A events, awarded following BWF's guidelines to Winners, Runners Up and Semi Finalists (maybe Quarter-finalists) depending on draw size.

\$2000.00 prize purse for B events.
