All board members, candidates for board offices, and paid staff are required to complete a conflict of interest statement that is reviewed by the ethics committee. All current board members and full time staff have completed the required forms and those forms are on file. In addition, the bylaws empower the ethics committee to ensure compliance on all board members and staff regarding issues of "material benefit" conflicts of interest, and the ethics committee is charged with administering and maintaining the code of ethics of the Organiztaion.
